To the 2018 Candidates for District License:

The Ministerial Credentials Board of the Virginia District and the entire Church of the Nazarene recognize the importance of protecting its ministers and congregations. The use of background checks has become a matter of standard operating procedure for churches in any number of settings (i.e., those who work with children and youth). The use of a background checks as part of the process for receiving a district license is really a matter of due diligence by the district and serves as a way to protect every applicant for ministry. The Credentials Board has discussed this matter and recommended that we find a reasonable way to implement this procedure. In accordance with the 2013-2017 Manual of the Church of the Nazarene (paragraph 530.1), the District Advisory Board has also adopted the policy.

The reports generated by www.backgroundchecks.com are maintained on their computers and servers. There is a one-time charge of \$20 per applicant, which should be attached to the release form and sent to the District Resource Center (DRC) at 5906 Harbour Park Drive, Richmond, VA 23112. We hope that you will see this expense as an investment in the ministry. We do appreciate your support.

(Please make note that the fee has changed to \$20.)
